INFORMATION/DISCUSSION First Reading of Proposed Student Handbook Revisions Kevin Weck, Dean/Assistant Principal of Westmont High School, presented the revisions being proposed to the elementary, junior high, and high school student handbooks by the Handbook Committee. The Board had some concerns regarding the proposed change in the Elementary Handbook concerning the lowest temperature at which the students will go outside for recess. Additional information will be provided at the next regular Board meeting on May 14, 2019. Mrs. Charlton questioned the proposed changes in Westmont High School's handbook relating to class rank, and how they came to be in this draft. She stated that this topic had been preliminarily brought to the Board a few years ago but had not been decided on. She also questioned if the District had to remove class rank from the individual student's transcript. Mr. Carey stated that our attorney will review recent Legislation and will bring this back to the Board when he has an answer.

Professional Development Needs for the 2019-2020 School Year The Principals collaborated with Nadine Norris, Director of Technology, Teaching, and Learning, to develop a professional development plan for the 2019-2020 school year. The plan includes consultants, workshops, and staff development for next school year.

Public Relations and Co-Curricular Coordinator After a discussion by the Board at the April 9, 2019 regular meeting of Community Unit School District 201 Board of Education, it was suggested that adjustments be made to the wording of the Co-Curricular job description to emphasize the public relations responsibilities. After deliberation, the Board decided to ask the Athletic Director committee to revisit the topic.

Phone System Replacement

In January, the District was notified by Midco, Inc., that Toshiba Corporation had sold their telecom business to Mitel Corporation and that technical support for our current phone system would end on October 31, 2021 and that the end of add on sales would be October 31, 2019. The end of add on sales of October 31, 2019 is a critical date for our phone system. As of that date, the District will no longer be able to transfer a license from a potentially bad CPU to a replacement CPU in any of our five phone switches (one located in each building). This would in effect render the switch useless and no longer operational and leave a portion of the District without phone service. The anticipated cost of a new phone system is approximately \$185,000 and includes the consultant cost. This has been added to the 5-year Capital Project list and is the number one priority

for our funding for 2019-20.

Capital Project Reporting

Kim Anderson reported that the Buildings and Grounds Committee met to review the School District's Capital project list through 2023-2024. The list included projects that may be able to be completed this fiscal year as well projects for future years. Mrs. Anderson reviewed the items that were suggested to be the highest priority. She also stated that a revised version will be brought to the Board following another meeting of the Buildings and Grounds committee, with more updated information.

SUPERINTENDENT'S REPORT Communications

Superintendent Carey reviewed the following discussion items with the Board of Education:

Registration for the 2019–2020 school year will take place at Westmont Junior High School on August 6, 2019 from 2:00 p.m. until 8:00 p.m. All families will register at the Junior High on August 6th, regardless of the age of their children or the schools their children attend. All families will need to prove residency at the time of registration. Registration information will be available on the District website after July 1, 2019.
