DISCUSSION/INFORMATION eLearning Days

Kevin Carey presented the Board with information about elearning. Public Act 101-0012 allows school districts to use elearning days in lieu of emergency days. School districts now have the option of having an e-learning day instead of canceling school and adding a day to the end of the school year or using a previously scheduled day off such as a holiday. The initial reason for looking into e-learning was because there has been concerns about tacking all of our "snow days" to the end of the school year calendar.

Kevin presented information that the Administration has preliminarily looked into how this would look in D201. There are a number of factors that go into this process. There was a discussion about the breadth of how e-learning would impact our district since we are a unit district with children from pre-k through high school.

The other option the Board discussed was to use some of the non-attendance days in the calendar as make up days for emergency or snow days. For example, if an emergency day is used prior to President's day, the holiday will become a school day. This will be in lieu of adding a day to the end of the year.

After much discussion, it was generally agreed that the Board would discuss this topic at the next meeting. One option discussed was using non-attendance days for the first two "snow days" and any other snow days would be made up at the end of the year. The Board stated that it was not interested in using Spring Break to make up snow days.

Joel Price exited the meeting at 8:08 p.m.

Enrollment projections were shared with the Board. Overall, the projections forecast an increase in enrollment. The Board requested monolingual and dual language enrollment figures.

Mrs. Anderson, Business Manager/CSBO, provided the Board of Education with a summary of projects slated for completion during the 2019-2020 school year as well as some maintenance items.

Mrs. Anderson thanked the custodial and maintenance staff for their hard work and support.

The goal of the Board of Education and District was to provide additional support for the promotion and development of a more comprehensive athletic and co-curricular program. In the past, the Board has discussed strengthening the athletic programs throughout the district. A committee was formed, and numerous conversations were had at Board meetings.

Kevin Carey provided the following information to the Board: "The goal of the Board of Education and District was to provide additional support for the promotion and development of a more comprehensive athletic and co-curricular program. It would be ideal to be able to propose a new fulltime administrative position to fill this need. This is not feasible when the District is anticipating a deficit budget, and there are equally pressing needs. In working with the Athletic Director Committee and the Westmont Teachers' Association, it is possible to grow the position by increasing the amount of release time the position currently has without increasing staffing or FTE. Currently, the position has .2 FTE release time. The amount of release time will

increase to .5FTE. This will allow the Athletic Director to begin to grow the athletic and co-curricular program and make connections with feeder programs. The hope is that the Athletic Director will also work with stakeholders to create a vision for athletics and co-curricular programs for CUSD 201. The possibility of a full-time position will be revisited at a future date."

There was another discussion at this Board meeting, and it was decided that it was time to vote on the issue. Board members expressed their thoughts and concerns with the position continuing to be a stipend position and were looking for further discussions to grow this into a full-time position.
