# DISCUSSION/INFORMATION Update Summer School

Superintendent Carey updated the Board on the 2020-2021 school year then gave the Board an update on Summer School. His presentation for the 2020-2021 school year included the following:

Superintendent Carey let the Board know the district is partnering with two pharmacies for the vaccine, Westmont Pharmacy and Osco Drug. Superintendent Carey shared how Sam from Westmont Pharmacy has gone well above and beyond to help us. The DCHD is currently prioritizing the distribution of the vaccine.

Superintendent Carey shared with the Board how our district will be a summer school site. Each district is responsible for the transportation of their students. Schools are responsible for identifying students who will benefit from summer school. The cost of operating summer school will be comparable to past years.

The Board addressed questions with Superintendent Carey regarding fourth quarter and returning to school for full days. There was discussion if the Board should vote or have Superintendent Carey set forth a plan.

Superintendent Carey shared a memo with the Board regarding the current hybrid model.

**COVID-19 Testing** 

Superintendent Carey gave a presentation regarding COVID-19 testing with the Board. His presentation included the following:

- Current Mitigation Measures
- Saliva Testing
- Purpose of Saliva Testing
- Testing Process

All testing would need to be voluntary. Even with the testing all other mitigation measures would still need to be met. Superintendent Carey shared how the testing may cause some students to end up staying home because their families will not have the means to get them tested further should they need to. Currently most schools using the testing are showing a low positive return rate.

iReady Update

iReady testing is just finishing up, Superintendent will provide an update at the next Board meeting.

Update on Tax Increment Financing (TIF) District Revenues Kim Anderson, Business Manager, shared an update with the Board on the current instalment of the TIF. To date the funds received for the TIF have been lower than projected.

Policy First Reading 4:120

Currently the Policy Committee is reviewing all policies. Our current policy 4:120 is out of date with the Press Policy. Policy 4:120 is being presented tonight for first reading. Superintendent Carey explained policies 4:81 and 4:82 are specific to our district and relate to finance. The Finance Committee will review them and determine if any changes are needed. It is being requested tonight that policies 5:38, 5:121, and 5:160 be retired. The policies have been reviewed by the district attorney and it has been determined they are covered by statute or other existing policies.

Mr. Armstrong requested permission to discuss the current IHSA guidelines on spectators and sports. It is being requested we allow some spectators at our home events
