DISCUSSION/INFORMATION

First Reading of Proposed Student Handbook Revisions

Assistant Principal, Dr. Kevin Weck, presented the changes being proposed in the first reading of the student handbooks. He highlighted the changes being proposed for the Elementary, junior high, and high school. The changes being proposed can be viewed in BoardDocs. Dr. Weck would like to thank everyone who is on the Handbook Committee. Final reading of the proposed changes

will be presented at the May 18, 2021 School Board meeting.

Smart Board Refresh

Nadine Norris, Director of Technology, Teaching, and Learning, updated the Board on the plan to implement Clevertouch Impact Interactive Boards in PreK-8th. Currently there are many Smartboards in the District that are not operating correctly and they are no longer serviceable. The District is looking to purchase 65 new boards. The installation would be done over the summer by an outside vendor. The purchase would be part of the technology refresh budget. Ms. Norris will return to the May 18, 2021, meeting to seek approval from the Board for the purchase.

Update on 2020-2021 School Year Superintendent Carey gave the Board an update on the 20-21 school year. He reviewed the guidelines and the current Covid numbers for the district and the surrounding communities. Currently DuPage County is working on a clinic for high school students 16 and up to receive the vaccine. The date will be shared when it is available. Superintendent Carey also gave an update on Summer School. This year it will be by invite only. The District has received money from the Elementary and Secondary School Emergency Relief Act. The budget will be shared at the May 18, 2021 meeting. Some of these funds will be used toward Summer School.

Strategic Plan Update

The Strategic Plan meeting scheduled for March has been postponed. Superintendent Carey will be reaching out to the Board to schedule a workshop with Administration. He would like to have the strategic plan finalized before July 1, 2021.

Elementary Future Planning

Superintendent Carey shared an update on the planning for the elementary schools. He would like to develop a task force to plan and provide recommendations for the long term. Next year Manning and Miller will continue to be grade level centers. There will be a brief application process for the taskforce and members are to commit to the dates of the meetings.

Capital Project Reporting

Kim Anderson gave an update on the capital projects. The projects that have been started or that will start in June have already been approved by the Board. Some of these projects include 10 year life safety projects and the Building Automation System at WHS.

Projects that are slated for the FY22 school year are marquee sign at WJHS and a new District Activity Bus. Another project to be addressed is the roof at WHS; the roof has sustained wind damage. The Board will be presented tonight a contract from Cashman Stahler to approve their services for architectural, engineering, and bidding for the project. Some other projects which are being discussed are the HVAC system at WJHS and the parking lots at South and Miller.
