Superintendent Carey shared with the Board that a vaccination clinic will be offered on January 29, 2022, at Westmont Junior High School. The clinic will be hosted by Westmont Pharmacy. He also let the Board know about a lawsuit that is currently being decided regarding mask and vaccine mandates in schools. The judge should be handing down his ruling later this week. Depending on the ruling, the District may have to review its policies.

Update on Tax Increment Financing (TIF) District Revenues Kim Anderson, CSBO gave the Board an update on the TIF. TIF money can only be spent on improvements at Manning. If down the road the District decided on one k-5 building, the money can only be used if it is at the Manning location. To date we have only received \$491,000 of the projected \$4.5 million projected for this time. The Board has asked if the Village can give us updated projections.

Masks at Co-Curricular Events

The Board discussed how to enforce the use of masks at extracurricular activities and how to help out the staff working these events. The Board discussed how to remind spectators to wear their masks and to have an announcement before each event. If a spectator has to be asked more than twice, they can be asked to leave. This request and the following of the rules regarding masks leads back to policy 8:30, Visitors to and Conduct on School Property.
