# DISCUSSION/INFORMATION Elementary Task Force Update

Lindsay Pietrzak, Principal, Manning Elementary School; Tim Wyller, Principal, Miller Elementary School; and Nadine Norris, Director of Technology, Teaching and Learning, presented, via PowerPoint, to the Board an update and recommendation from the Elementary Task Force.

Ms. Pietrzak started the presentation by discussing the "Why."

- Examining the Status Quo
- The Why?
- Optimal Systems
- Programming
- Sustainability

Mr. Wyller continued the presentation discussing Equitable opportunities for all.

- Equity Low Income
- Equity English Learners
- Equity Demographics

Superintendent Carey discussed the goal of the task force was to "examine various building configurations and bring two options to the Board in the Fall 2021." They held four meetings and had 30 members including administration, staff, parents, future parents and community members. They came up with three different options. The three options are:

- Grade Level Centers
- One k-5 building
- Two traditional k-5 buildings

Superintendent Carey reviewed the strengths and challenges of each of the options.

Ms. Norris, reviewed the results of the survey.

The recommendation to the Board is the following:

- One k-5 building (keep current k-1 and 2-5 model in the interim)
  - Next Steps: Research feasibility of either build a new school or add on to an existing school to accommodate current and future needs.
- If one k-5 building is not feasible, keep current k-1 and 2-5 model in place.
  - Next Steps: Invest efforts into researching on k-5 building, develop transportation, plan for both building, build master schedule that connects both buildings, and align programs and build succinct transition plans to help students move from one building to another.

The Board discussed and asked questions regarding the presentation. The Board discussed how equity is the most important thing. Mr. Hevia asked for a clear direction on the recommendation.

Ms. Anderson gave an update on the October financials to the Board. Her presentation included an update on revenues received from the state, including property taxes. She also gave an update of revenues and expenditures for the month of October in the Education & Tort Funds, Operations & Maintenance/Life Safety Funds, and Transportation Funds.

If the District chooses to have e-learning days on hand as an option, there usage would be decided by Mr. Carey as the situations arise.
