IASB Superintendent Search

Sex Education Legislation

Superintendent Carey reviewed the policy regarding mandated units of study. At this time, we do have a policy in place from the Illinois State Board of Education regarding many aspects of curriculum, which includes sexual health. What is listed in the policy is different than the National Sex Education Standards. In 2022-2023 districts can choose to teach what they currently have in place. This school year nothing is changing for CUSD 201. Over the course of the school year the Board can look at the curriculum. The Board has asked for the District to put together a document of what we are currently teaching in the sex education curriculum.

TCD/DAOES Joint Agreement

new districts and what each group would financially earn if the TCD land were to be sold.
